Digital reporting for courts and the record will see massive changes in the near future. The COVID-19 virus has forced the courts to change how they have traditionally done business, moving from in-person to electronic communication. Digital reporting, digital transcription, e-signature, and support for web conferencing will all be increasingly used and enhanced by the application of artificial intelligence. This session will discuss what the courts are already doing but also what is being planned.

The problems that the legal field has faced with the current COVID-19 crisis is forcing us to all look at how we conduct legal proceedings in a different way utilizing video conferencing. requirements for administering the oath. Courts have responded by coordinating remote hearings via video conferencing. Now we, the court reporting community, must respond by becoming experts on reporting these new proceedings while maintaining the quality of the record and the production of the verbatim transcripts. Certification Exams Update

In February, 2020, AAERT adopted concurrent testing for CER and CET exams, moving away from the previous testing cycles, allowing a more convenient means of scheduling. On March 22nd, we were notified that our testing vendor had suspended their proctor centers due to a government shutdown of all non-essential facilities in India due to the COVID-19 pandemic.

At this time we are actively working with the vendor to determine our next steps. They are trying to secure a number of proctors for a work at home solution. For this, they need to provide a computer and all the necessary equipment to make this happen. We feel confident with the integrity and security of the exams and the recording process that we have in place (of both candidate and proctor).

We have been advised that we can open up the scheduling dashboard on April 20th, 2020. We are limited to 5 slots per day at this time until our proctors are back to normal capacity. We expect to receive a follow up to the status of the lock down in India in the next few days to determine when they hope to be back to normal capacity. At this time, we will begin scheduling the CER and CET knowledge exams.
